<b>Promotional Period:</b>	<p><b>Start time/date:</b> 09:00 am AEDT on 13/02/26</p> <p><b>End time/date:</b> 11:59 pm AEDT on 27/03/26 or once 40 valid team registrations are received (whichever occurs first)</p>
<b>Eligible entrants:</b>	<p>Entry is only open to NSW residents who are 18 years of age or over.</p> <p>For the sake of clarity, the team captain and their team members (as set out in more detail below) must all comply with the eligibility requirements above.</p>
<b>How to Enter:</b>	<p><b>Team Captain Registration Requirement:</b> To register, an eligible entrant must complete the following steps during the Registration Period:</p> <ol style="list-style-type: none"> <li>visit <a href="https://www.hahn.com.au/campaign/3x3-team-registration">https://www.hahn.com.au/campaign/3x3-team-registration</a>, follow the prompts to the Promotion entry page; and fully complete and submit the online entry form with their personal details (first name, last name, date of birth, email address, mobile number and post code), their 'team name'; and</li> <li>enter the email addresses of two (2) to four (4) friends aged 18 years or over ("Team Members"), ensuring they have obtained each Team Members permission to provide their details.</li> </ol> <p>Team names must be suitable for wider publication and not objectionable, encourage irresponsible consumption of alcohol, infringe on any third party rights or be otherwise against public interest in any way. Individuals who submit unsuitable team names may be disqualified immediately or asked to change their team name (in the absolute discretion of the Promoter).</p> <p><b>Team Member Registration Requirement:</b> To complete their team's registration, the Team Members must, during the Registration Period, visit the Team Link, follow the prompts to the Promotion entry page; and fully complete and submit the online entry form with their personal details (first name, last name, date of birth, email address, mobile number and post code).</p> <p>The individual who registered the team will be referred to as the 'Team Captain' for the purpose of these Terms and Conditions and individuals who join the team will be referred to as the 'Team Members'.</p> <p>Only the first 40 teams to successfully register will receive the opportunity to participate in the 3x3 basketball tournament ('Tournament'). For the sake of clarity, a team must consist of at least three (3) players (up to five (5) players) (including the Team Captain) ("Team"). It is the Team Captain's responsibility to have all Team Members complete their registrations within the Registration Period. In the event a Team is incomplete at the end of the Registration Period (i.e. there are not at least three (3) players registered), that Team will not be eligible to participate in the Tournament.</p>
<b>Tournament Details:</b>	<ul style="list-style-type: none"> <li>Once the Registration Period has ended, successfully registered Teams will be invited to take part in a Tournament. The Tournament will run for a period of one (1) day with 40 Teams competing. The format of the Tournament will be 3 vs. 3 (with up to two (2) rotating bench players). The Promoter will communicate any rules regarding the Tournament on the day.</li> <li>The Tournament will be held at Throwback, 100 William Lane, Alexandria, NSW 2015 ("Venue") on 08/03/26. Exact times of the Tournament and each game will be determined by the Promoter and will be communicated to the Team Captain. If a Team (or any Team Member) is unavailable on the date(s) required by the Promoter, they will forfeit their right to participate and will not be awarded cash, or any other alternative in lieu.</li> </ul>

	<ul style="list-style-type: none"> <li>• All costs associated with travel to and from the Venue will be the responsibility of the Team Captain and Team Members.</li> <li>• The tournament will follow a knockout-style format, with teams eliminated after each round.</li> <li>• The last team remaining at the end of the tournament will be deemed the Winning Team and will receive the prize outlined below. Non-winning Teams will not receive any consolation prize.</li> <li>• Team members must possess appropriate levels of fitness, health, skill, balance, dexterity and other personal characteristics so as to be able to safely participate in the Tournament. Each member of a Team must carefully assess the levels of fitness, health, skill, balance, dexterity and other personal characteristics required of them to take part in the Tournament. Members must immediately withdraw from the Tournament if they may not satisfy any of the required levels of fitness, health, skill, balance, dexterity or other personal characteristics. The Promoter may require entrants to submit information relating to their fitness, health, skill, balance, dexterity or other personal characteristics. Acceptance of a Team Member by the Promoter following receipt of this information in no way: (a) constitutes a representation or assurance that they are suited to undertake the Tournament; or (b) relieves them of the obligation to assess the requirements of the Tournament and to withdraw if there is any doubt regarding their suitability.</li> <li>• If the Team Captain and/or any Team Member acts in a disorderly manner or is physically or verbally abusive or is disruptive to the peaceful implementation of the Tournament, they may at the promotional staff member's discretion be asked to leave and may forfeit their or their Team's chance to participate in the Tournament and/or their or their Team's right to a prize</li> <li>• The Team Captain and Team Members will be required to sign an additional release and indemnity form as provided by the Promoter (and any other paperwork required by the Promoter in its absolute discretion).</li> </ul>

The Promoter and event organisers hereby expressly reserve the right to eject any team member for any inappropriate behaviour, including but not limited to intoxication, whilst participating in any element of the prize.</li> <li>• All costs associated with travel to and from the Major 3x3 Slam Tournament will be the responsibility of the winning team.</li> </ul>						
<b>Winner notification:</b>	The Winning Team will be notified at the completion of the Tournament and contacted via email within seven (7) days of the Tournament.						
<b>Unclaimed Prizes:</b>	In the event of an unclaimed prize, the Promoter may at its discretion assign the prize to the entry judged the next best team, conduct a further judging to award the prize, or withdraw the prize unawarded. The Promoter is under no obligation to award any unclaimed prize.						

1. The entrant agrees and acknowledges that they have read these Conditions of Entry (and Schedule) and that entry into the Promotion is deemed to be acceptance of these Conditions of Entry (and Schedule). Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, unless stated otherwise.

2. The Promotion commences on the Start Date and ends on the End Date ("Registration Period"). Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.
3. Valid and eligible entries will be accepted during the Promotional Period.
4. Employees (and their immediate family members) of the agencies/companies directly associated with the conduct of this Promotion, the Promoter, businesses involved in determination of winner/s for the Promotion, businesses involved in the management of the Promotion, any organisation benefiting from the Promotion, the Promoter's distributors, suppliers, subsidiary companies/businesses and associated companies and agencies are not eligible to enter.  
"Immediate family member" means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
5. All reasonable attempts will be made to contact each Winning Team.
6. If any Winning Team chooses not to take their prize (or is unable to), or does not take or claim a prize within a reasonable time, as specified by the Promoter, or is unavailable, they forfeit the prize and the Promoter is not obliged to substitute the prize.
7. The value of the prizes is accurate and based upon the recommended retail value of the prizes (inclusive of GST) at the date of printing. The Promoter accepts no responsibility for any variation in the value of the prizes after that date.
8. No part of a prize is exchangeable, redeemable for cash or any other prize or transferable, unless otherwise specified in writing by the Promoter.
9. If a prize (or portion of a prize) is unavailable the Promoter reserves the right to substitute the prize (or that portion of the prize) to a prize of equal or greater value and specification.

12. Entrants' personal information will be collected by the Promoter. Personal information will be stored on the Promoter's database. The Promoter may, if the entrant selects the respective tick box on entry, use this information for future marketing purposes regarding its products, including contacting the entrant electronically. The Promoter is bound by the Australian Privacy Principles in accordance with the Privacy Act 1988 (Cth) and its privacy policy which is located at <https://www.lionco.com/legal/privacy-policy>. The Promoter's privacy policy contains information about how the entrant may access, update and seek correction of the personal information the Promoter holds about them and how the entrant may complain about any potential breach by the Promoter of the Australian Privacy Principles or any other Australian privacy laws and how such complaints will be dealt with. The Promoter collects personal information about entrants to enable them to participate in this Promotion and may disclose the entrants' personal information to third parties including its contractors and agents, prize suppliers and service providers to assist in conducting this Promotion and to the State and Territory lottery departments as required under the relevant lottery legislation. If the entrant does not provide their personal information as requested, they may be ineligible to enter or claim a prize in the Promotion. Personal information collected from entrants will not be disclosed to any entity located outside of Australia.

14. If a prize is provided to the Promoter by a third party, the prize is subject to the terms and conditions of the third party prize supplier. The terms and conditions which apply to the prize at the time it is issued to the winner will prevail over

these Conditions of Entry in the event of any inconsistency. To the extent permitted by law the Promoter accepts no responsibility or liability for any delay or failure by the third party to deliver the prize, any delay or failure relating to the prize itself or failure by the third party to meet any of its obligations in these Conditions of Entry or otherwise.

15. Any guarantee or warranty given is in addition to any relevant statutory guarantees and warranties and nothing in these Conditions of Entry restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the Competition and Consumer Act 2010 (Cth).
16. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.
17. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. The use of any automated entry software or any other mechanical or electronic means that allows an individual to automatically enter repeatedly is prohibited and may render all entries submitted by that individual invalid. The Promoter reserves the right to disqualify any individual who provides false information, fails to provide information, conspires with others to gain an unfair advantage or is otherwise involved in any conduct that involved manipulating, interfering or tampering with this Promotion or otherwise preventing the conduct of the Promotion as intended by the Promoter.
18. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Conditions of Entry. In the event that there is a dispute concerning the conduct of the Promotion or claiming a prize, the Promoter will resolve the dispute in direct consultation with the entrant. If the dispute cannot be resolved the Promoter's decision will be final.
19. Unless otherwise specified, a prize is a single event for the winning team and cannot be separated into separate events or components.
20. The Winning Team will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the Promotion, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledges that the Promoter may use any such marketing and editorial material without further reference or compensation to them.
21. The Promoter accepts no responsibility for any tax implications and the entrant must seek their own independent financial advice in regards to the tax implications relating to the prize or acceptance of the prize.
22. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of these rights.
